This job description may be amended at any time following discussion between Head and member of staff, and will be reviewed annually.

- To support the development and on-going review of the primary school's MFL assessment procedures in liaison with class teachers.
- To work effectively to ensure that there is progression across the year groups.
- To take every opportunity of developing children's basic social and educational skills and to assist in the development of their listening and speaking skills.
- To plan for a range of abilities so that all children reach their potential.
- To lead and implement MFL strategies throughout the school and to co-ordinate all MFL events including extra-curricular, clubs and assemblies.

## **Classroom Management and Organisation:**

- To teach and actively promote the schools core values and positive reinforcement approach to behaviour management
- To follow the schools nurturing principles to maintain a well-ordered, calm environment that is stimulating and purposeful.
- To ensure that all equipment is organised and accessible to children so that it encourages independent learning.
- To organise an inclusive learning environment.
- To maintain assessment records as specified in the School's assessment schedule.
- To direct Teaching Assistants whilst french learning is taking place and to monitor tasks they are expected to undertake.

## **Safeguarding and Inclusion**

- To be individually responsible for promoting and safeguarding the welfare of children.
- To take account of each child's home language and culture ensuring this is reflected in displays, materials and throughout the curriculum.
- To provide a safe, welcoming and positive atmosphere for parents that will establish strong links with the School.
